**SUPPLY & DELIVERY OF HARDWARE & CONSTRUCTION SUPPLIES FOR THE CONSTRUCTION OF FENCE AT ARCHIVES & DORMITORY BUILDINGS- REBID**

1. The DAVAO REGIONAL MEDICAL CENTER (DRMC), through the MOOE CY 2017 intends to apply the sum of *One Hundred Eighteen Thousand Six Hundred Eighty-four pesos & 65/100 only (PhP118,684.65)* being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply & Delivery of Hardware & Construction Supplies under IB number 17-02-018. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The DAVAO REGIONAL MEDICAL CENTER now invites for the procurement of the above- caption package. Delivery of the Goods is specified in the Schedule of Requirements. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from the BAC Secretariat, Procurement Section, Davao Regional Medical Center, Apokon, Tagum City and inspect the Bidding Documents at the address given below during 8:00 A.M. to 5:00 P.M.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **February 13-21, 2017** from the address below and upon **PAYMENT OF A NON-REFUNDABLE FEE** for the Bidding Documents pursuant to the latest Guidelines issued by the GPPB, in the amount of PhP500.00

It may also be downloaded free of charge from the website of the Philippine Government Procurement System (PhilGEPS), provided that Bidders shall pay the non- refundable fee for the Bidding Documents not later than the submission of their bids.

6. The date and time of submission of Bids will be on **February 21, 2017, 9:00-9:30 A.M.** at the **BAC Office, Admin Building**, DRMC, Apokon, Tagum City or delivered to the address below on or before the scheduled date and time of submission. Late Bids shall not be accepted.
7. Bids will be opened on **February 21, 2017, 9:30 A.M.** at the **BAC Office, Admin Building**, DRMC, Apokon, Tagum City in the presence of the Bidder's representatives.

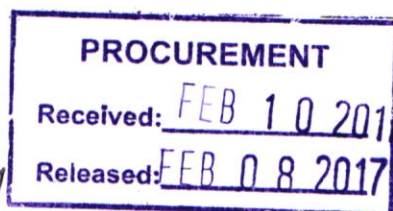
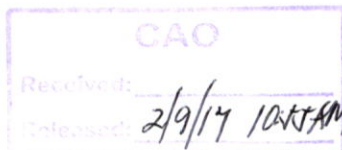
All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
