The DAVAO REGIONAL MEDICAL CENTER, through the General Appropriation Act (GAA) intends to apply the sum of **Four Million Nine Hundred Ninety-nine Thousand Nine Hundred Ninety-nine pesos & 06/100 only (PhP4,999,999.06)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Upgrading of Motor pool & Laundry Building**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The DRMC, now invites bids for the procurement of the above-caption package. Completion of the Works is required by One Hundred Twenty (120) calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents particularly in Section II the Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from the BAC Secretariat, Procurement Section, Davao Regional Medical Center, Apokon, Tagum City and inspect the Bidding Documents at the address given below during 8:00 A.M. to 5:00 P.M.

A complete set of Bidding Documents may be acquired by interested Bidders on **February 23, 2017 to March 14, 2017** from the address below and upon **PAYMENT OF A NONREFUNDABLE FEE** for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos Only PhP5,000.00.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

The DRMC will hold a Pre-Bid Conference open to all interested parties on **March 2, 2017, 10:00 a.m.** at **RDR Conference Hall, Admin Building, DRMC, Apokon, Tagum City**

The date & time of submission of Bids will be on **March 14, 2017, 9:00-9:30 a.m.** at the **RDR Conference Hall, Admin Building, DRMC, Apokon, Tagum City** or delivered to the address below on or before the scheduled date and time of submission. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

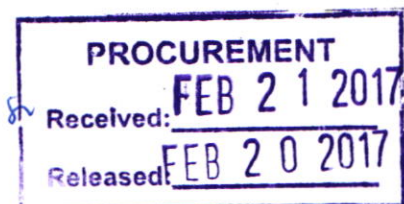
